#### UNDP Course on Gender and Mining Governance (MOOC)

In September 2021, the United Nations Development Programme (UNDP) ran, for a second year, a free Massive Online Open Course (MOOC) on Gender and Mining. It was a four-week course offered in English, French and Spanish and covered the topics of gender and mining governance (week 1), women's participation in decision-making in the mining sector (week 2), gender-based violence in the mining sector (week 3) and

investment in gender in mining governance (week 4). WRM's research was used to help develop the week 3 lecture on SGBV and mining.

#### **WRM-OECD Gender Statement**

The WRM-OECD "Stakeholder Statement on implementing gender-responsive due diligence and ensuring the human rights of women in mineral supply chains" was launched at the OECD's 2019 Forum on Responsible Mineral Supply Chains. It includes 13 commitments on how states, the private sector and civil society can work together to prevent gender inequalities along mineral supply chain. ## Gender integration into international mining standards

To increase the gender responsiveness of mining policy and practice, WRM regularly contributes to stakeholder consultations and reviews of international mining policies, regulation, standards and guidelines:

- In July 2021, WRM contributed to the review of RMI's Global Due Diligence Standard.
- In July 2021, WRM submitted comments to the LBMA Responsible Gold Guidance.
- In November 2021, WRM participated in the review of the Forest-Smart Artisanal Small-Scale Mining Standard and Guidelines, as commissioned by the World Bank and developed by Levin Sources, ARM and Fauna & Flora International.

#### WRM at OECD Forum on Responsible Mineral Supply Chains, May 2022

For the sixth consecutive year, WRM will be active at OECD's Forum on Responsible Mineral Supply Chains:

- WRM has provided recommendations to the OECD, and is working in collaboration with them, on how to improve the Responsible Mineral Supply Chain Forum in terms of diversity, inclusivity and content, and increasing sensibility and awareness of the need for the integration of gender concerns in panels

- WRM helped revise the panel descriptions for the OECD forum to integrate a gender lens.

#### Knowledge Platform Review – Summary of results

In 2021, WRM undertook internal and external scoping to elaborate a Knowledge Platform strategy. Online resources and thematic events are rebranded under the Knowledge Platform. The goal, in the long term, is to

create an interactive community in which one can consult, submit and share questions, assistance and resources. The Knowledge Platform plans to focus on the following aspects:

- Regular knowledge exchange among members
  - Organize Knowledge Platform events three times per year if possible during relevant conferences or other moments when members and other mining sector stakeholders come together.
  - o Ensure follow-up to events and communicate information shared broadly.
- An inclusive Knowledge Platform
  - o Connect with relevant networks and/or NGOs in producing countries and expand the membership of Knowledge Platform
    - Host hybrid events with local/regional partners and focus. The local event is followed up by an online event.
  - o Translate WRM products and website to French and Spanish
  - o Targeted social media posts in the language of the relevant area/region
- Create a central digital platform of resources on gender and mining: an online digital community which serves not only as a resource base, but that also connects KP members
  - o Expand and catalogue the <u>resource section</u> on the WRM website
  - o Explore possibilities for collaboration with other knowledge platforms
  - o Create practical knowledge products, such as the '10 do's'.
  - o Promote relevant gender and/or mining events on a calendar on the website
- Increase the visibility of WRM's work
  - Annual newsletter
  - o Continuously promote the work of the WRM via different media channels
